NOTICE

The code allows for on-street parking privileges in designated Resident-Only parking Areas during the hours of 7:30 a.m. to 5:30p.m. for vehicles displaying a resident permit decal or a visitor's permit card. The permit is valid until August 15th following it's purchase, and applications for renewal must be made annually between August 1st and August 15th. The cost of the permit is \$5.00 for first set & \$5.00 for each additional permit. The decals are not transferable from vehicle to vehicle or owner to owner. The color of the sticker will designate the year and location of validation. **PLEASE NOTE: YOUR PERMIT ALLOWS YOU TO PARK ONLY ON YOUR BLOCK FOR WHICH THE PERMIT WAS ISSUED.**
The sticker is to be displayed in the upper left hand corner of the rear window (driver's side).

SUBJECT: RESIDENTIAL PARKING PERMITS 2010-2011

Once again it's time to issue Residential Parking Permits for 2010-2011. Permits can be purchased at the **Pocatello Police Records Department at 911 N. 7th Ave.** Office hours will be Monday-Friday 8:00 a.m. to 5:00 p.m.

NEW APPLICANTS: you will need to fill out an application form (one has been enclosed for your convenience) bring completed application along with proof of residence (rental agreement, utility bill, etc.) the vehicle registration for each vehicle listed on the application and Photo ID

RENEWALS: if ALL of your information is exactly the same as last year, include the completed and signed form, along with the payment and mail to the Pocatello Police Dept.-Records Division 911 N 7th Ave Pocatello ID 83205. We will send your permits back to you through the mail once the information is verified. **Tags-First set \$5.00 (consists of one sticker and one visitor tag), any additional sticker/visitor tags are \$5.00 each. Per ordinance and limitations listed on back of this letter.**

See reverse side of this letter for the outline of the Residential Parking Program. Please take note of the fees, which have not changed from last year, and also the number of permits that will be issued. *For additional questions regarding permit prices, please call our office at 234-6108.* Also, pay close attention to the section concerning the limitations on parking in the permit areas.

Again this year, the stickers will be color coded by areas of the city i.e., ISU, Highland High School, and Pocatello High School will each have different colors. (The permit colors will be different from what they were last year so make sure you change your permits.)

The permits are color coded so the Police Department will be able to easily differentiate between expired and current stickers and those parking illegally. Anyone using an expired sticker after August 20, 2010, will be cited the same as a person with no sticker at all.

RESIDENTIAL PARKING ORDINANCE
EFFECTIVE AUGUST 2002

Section 3. 10.34.040 Permits – form – application – fee required

B. Applicants must appear in person and sign and complete a form provided by the City, certifying their status as full-time residents, or other parties eligible under this Chapter, and present proof of identification, address, current vehicle registration, and license plate number. Owner of residential rental property, who reside outside the area, may receive one visitor tag upon presentation of proof of ownership of the property and payment of the required fee in addition to the requirements listed above. FEES SHALL BE NON-REFUNDABLE AND SHALL NOT BE PRO-RATED. Fees for the 2010-2011 program shall be as set forth herein.

1. Single dwelling - 1 set (1 decal and 1 visitor tag); maximum of 2 decals and 2 tags per dwelling.

2010-2011 fee: \$5.00 for first set; \$5.00 each per extra decal or tag.

2. Multiple dwelling structure – 1 set per unit; maximum of 2 decals and 1 visitor tag per unit; non-resident landlord allowed one visitor tag.

2010-2011 fee: \$5.00 per set; \$5.00 for extra decal; \$3.00 for landlord tag.

Additional decals or tags may be issued, upon receipt of the appropriate fee, if the Traffic Engineer or designee determines that extenuating circumstances warrant the deviation. Fees for 2010-2011 for extra decals or visitor's permits shall be \$5.00 each; for replacement of lost visitor tags, \$3.00.

Section 4. 10.34.060 Limitations on Parking in Permit Area

A. PERMIT HOLDERS AND/OR VISITORS SHALL BE ALLOWED TO PARK ONLY ON EITHER SIDE OF THE STREET BETWEEN THE INTERSECTING SIDE STREETS, ON THE BLOCK ON WHICH THE PROPERTY(IES) FOR WHICH THE PERMIT HAS BEEN ISSUED IS (ARE) LOCATED.

Section 5. 10.34.080 Unlawful use of decals or permits

B. It shall be unlawful and a violation of this Chapter for a person possessing visitor tags issued pursuant hereto to permit the use or display of such tag on a vehicle parked in the resident-only area unless the driver/occupants are on the premises or inside the residence for which the permit was issued while the vehicle is so parked.
