

**CITY OF POCATELLO  
INVITATION TO BIDDERS**

Sealed bids will be received by the City Clerk, at the Municipal Building, 911 North 7th, P. O. Box 4169, Pocatello, Idaho, 83205, until 2:00 p.m. Mountain Standard Time (MST), **January 10, 2012**, at which time bids will be publicly opened and read for:

**ONE (1) NEW OR USED ASPHALT PAVER  
(2007 OR NEWER WITH 2,000 HOURS OR LESS)  
(Street Operations Department)**

Each proposal shall be on the form prepared by the City of Pocatello and shall be accompanied by bidder security in an amount equal to five percent (5%) of the total amount bid, in one of the following forms:

- a. Cash
- b. Cashiers check made payable to the City of Pocatello
- c. Certified check made payable to the City of Pocatello
- d. Bid bond executed by a qualified surety company, made payable to the City of Pocatello

As a guarantee the bidder will, if successful, enter into a contract and furnish the required bonding and insurance in a form approved by the City of Pocatello. In addition, the bidder must possess a current license, appropriate to the bid, to work in the City of Pocatello.

Detailed specifications and bid documents may be examined and obtained at the Office of the Street Superintendent, Street Operations Department, 1080 S. 1<sup>st</sup> Avenue, Pocatello, Idaho, Monday through Friday, 7:00 a.m. through 3:30 p.m., during regular business hours. **Additional information may be provided after initial specifications have been issued. Therefore, prospective bidders must contact the department bidding the equipment prior to submitting a bid to obtain a complete bid package in order for the bid to be considered responsive.**

If any bidder has any objections to, or desires to change any of the requirements of these bid documents, this must be made known in writing and delivered or faxed to the office of the Street

Superintendent, 1080 South First Ave. Pocatello, Idaho,  
(Fax 208-478-7152) no later than 12:00 p.m. (noon), January 3, 2012,  
for consideration.
