The purpose of the agenda is to assist the Council and interested citizens in the conduct of this public meeting. **Citizens should examine the agenda for the item of their interest. However, citizens are advised that only Public Hearings allow for public comment during the discussion/consideration process.**

Citizens have an opportunity to be heard by the Council if the item meets the criteria as described in the agenda item called "DISCUSSION ITEMS." You must sign in at the start of the meeting to be recognized.

RECESS: In the event the meeting is still in progress at 7:30 p.m., the Mayor may call a ten-minute recess to allow Council members and participants a brief rest period.

2. INVOCATION

3. CONSENT AGENDA

The following business items may be approved by one motion and a vote. If any one member of the Council so desires, any matter listed can be moved to a separate agenda item.

(a) MINUTES: Council may wish to waive the oral reading of the minutes and approve the minutes from the April 5, 2018 City Council Liaison Work Lunch; the April 12, 2018 Executive Session and the April 17, 2018 Pocatello/Chubbuck Mayor's Youth Advisory Council Luncheon.

(b) PAYROLL AND MATERIAL CLAIMS: Council may wish to consider payroll and material claims for the month of April 2018.

(c) POCATELLO ARTS COUNCIL APPOINTMENT: Council may wish to confirm the Mayor's appointment of Mark Cooper to serve as a member of the Pocatello Arts Council, replacing Ryan Babcock whose term expired. Mr. Cooper's term will begin May 4, 2018 and will expire May 4, 2021.

(d) POCATELLO ARTS COUNCIL REAPPOINTMENT: Council may wish to confirm the reappointment of Mark Neiwirth to continue his service as a member of the Pocatello Arts Council. Mr. Neiwirth's term will begin May 2, 2018 and will expire May 2, 2021.

(e) POCATELLO DEVELOPMENT AUTHORITY APPOINTMENTS: Council may wish to confirm the Mayor's appointments of Matt Bloxham and Robert Lion to serve as members of the Pocatello Development Authority, replacing Russ Meyers and Larry Fisher respectively. Mr. Bloxham's term will begin May 4, 2018 and will expire May 1, 2019. Dr. Lion's term will begin May 4, 2018 and will expire May 1, 2022.

(f) POCATELLO DEVELOPMENT AUTHORITY REAPPOINTMENT: Council may wish to confirm the reappointment of Brian Blad to continue his service as a member of the Pocatello Development Authority Board. Mr. Blad's term will begin May 1, 2018 and will expire May 1, 2022.

(g) COUNCIL DECISION—THE CROSSINGS DIVISION ONE FINAL PLAT: Council may wish to adopt its decision approving the Final Plat for The Crossings Division 1, which subdivides approximately 37.31 acres of land into ninety seven (97) lots, subject to conditions. The property is located east of Interstate 15 and north of East Chubbuck Road and the future extension of Olympus Drive.

(h) COUNCIL DECISION—RIVERSIDE GREENS TOWNHOUSE SUBDIVISION THIRD ADDITION SHORT PLAT: Council may wish to adopt its decision approving the Short Plat for Riverside Greens Townhouse Subdivision 3rd Addition, which subdivides approximately .62 acres of land into four (4) townhome lots, subject to conditions. The property is located east of Bannock Highway and South of Lundberg Lane.

(i) COUNCIL DECISION—SUNNYGROVE SUBDIVISION SHORT PLAT: Council may wish to adopt its decision approving the Short Plat for Sunny Grove Subdivision, which subdivides approximately .80 acres of land into two (2) townhome lots, subject to conditions. The property is located at the end of Corsini Court.

You must sign in at the start of the meeting in order to be recognized. **(Note: Total time allotted for this item is fifteen (15) minutes, with a maximum of three (3) minutes per speaker.)**

PUBLIC HEARING PROCEDURE

1. Explanation of hearing procedures by Mayor or staff.
 - Ten (10) minute time limit on applicant presentation.
 - Three (3) minute time limit on public testimony.
 - Names and addresses are required from those presenting/testifying.
 - Questions/comments should be addressed to the Mayor and Council.
 - Council members must make their decision regarding the application on facts already in the record and information presented at the public hearing. Conflicts of interest, site visits and ex-parte contacts by Council members will be acknowledged.
 - Protocol requires that Council and audience be recognized by the

Mayor prior to speaking.

2. Mayor opens hearing.

3. Presentation by applicant.

Note: Remember, applicant bears the responsibility for making his/her case. This is also the time for Council members to ask their questions of the applicant.

4. Presentation by staff.

5. Written correspondence submitted for the record.

6. Testimony by those supporting the application.

7. Testimony by those uncommitted on the application.

8. Testimony by opponents to the application.

9. Rebuttal by the applicant.

10. Mayor closes the hearing and initiates motion/deliberations.

Note: The Mayor may choose to require a motion prior to the discussion in order to focus deliberations, or, the Mayor may choose to allow deliberations prior to the motion in order to facilitate wording of the motion.

11. Develop a written and reasoned statement supporting the decision.

READING OF AN ORDINANCE PROCEDURE

1. Council determines which option below will be used to read the Ordinance by roll call vote.

2. The Ordinance is read by City Staff (usually City Attorney).

3. Mayor will declare the final reading of the ordinance and ask "Shall the Ordinance pass?" After roll call is taken, Mayor will announce whether or not the ordinance passed.

The Council has the following options for reading ordinances. If the Council makes no motion, the ordinance will be read on three (3) different days, two (2) readings of which may be by title only and one (1) reading of which shall be in full and placed on final passage for publication.

EXAMPLE MOTIONS:

Option 1: FOR ONE READING UNDER RULES SUSPENSION: "I move the ordinance, Agenda Item #__, be read only by title and placed on final passage for publication, and that only the ordinance summary sheet be submitted for publication."

Option 2: FOR THREE SEPARATE READINGS: "I move the ordinance, Agenda Item #__, be read on three separate days. First and second readings will be by title and in full on the third reading. The ordinance shall then be placed on final passage for publication, and only the ordinance summary sheet be submitted for publication."

Before the ordinance can be read under Option 1, the Council must pass said motion by a vote of one-half plus one (4) of the full Council.
