(Tasers)

I have reviewed the documents associated with the above-referenced surplus declaration and proposed trade. I have also had discussions with Detective Tracy Marshall, PPD, about the disposition of these Tasers.

I would recommend that that the Council declare these Tasers as surplus and authorizes the Police Department to dispose of these firearms as outlined in Det. Marshalls' Executive Summary, dated April 4<sup>th</sup>, 2020. I also recommend that the Council authorizes the Mayor to sign any documents to effectuate the sale/transfer. # Executive Summary

Date: April 4<sup>th</sup>, 2020

Request: Request to sell all Taser X-26, most of the Taser X-26P's, and most of the batteries and cartridges to Accredited Security, LLC, in Naples, Florida.

From: Detective Tracy Marshall, Pocatello Police Department

The Pocatello Police Department is requesting permission to sell older and outdated Tasers and equipment to Accredited Security, LLC, in Naples, Florida. Accredited Security, LLC, is a company that purchases old Taser Equipment, refurbishes it, and then sells it to other police agencies.

Staff are asking for the following:

Accept the purchase agreement from Accredited Security, LLC to sell approximately 68 Taser X-26 with holsters, as well as 42 Taser X-26P with holsters, 38 training cartridges, 113 duty cartridges, 32 new Taser X-26 batteries (DPM's) and approximately 59 old DPM's.

The selling price for the Taser X-26 is based on a sliding scale depending on the serial number series ranging from \$100 to \$200 per unit. The selling price for the Taser X-26P is \$200 per unit. The selling price for the new DPM's is \$20 per unit and for old DPM's is \$5. The selling price for the cartridges is \$5 per unit. The money received from the purchase of these items will be placed into the Pocatello Police Department budget through a budget ammendment.

The police department has transitioned to the Taser 7 and is no longer in need of the Taser X-26 or the Taser X-26P's. By selling these items that are no longer being used by the police department, will allow for staff to use the money to further the police department's goals, extend its budget, and obtained needed equipment.
