**POCATELLO PARKS & RECREATION ADULT PARTICIPATION WAIVER - AGREEMENT WAIVER, and RELEASE ATHLETIC LEAGUE**

I do hereby for myself, my heirs, executors, administrators, successors, and assigns, and on behalf of my minor child, waive, release, acquit, and forever discharge the City of Pocatello, its employees, contracted game officials, all entities that provide practice facilities or other persons whose services are contracted for (collectively "agents") from any and every claim, demand, right, or cause of action, property damage, personal injury, costs, loss of service, expenses of any kind, and any compensation whatsoever, which I may ever assert by reason of my or my child's presence and/or participation in any recreation program, including any claims which may arise from the alleged negligence or wrongful acts of the City of Pocatello, its employees, and/or its agents or from natural, environmental or weather condition, and all claims which might arise from any use of any equipment which might be attached to or near any structures or appurtenances on the premises, or used in conjunction with any recreation program, and all claims which might arise out of the acts or omissions of other persons on the premises, whether directly connected to any recreation program or not. I hereby authorize and allow the Parks and Recreation to use my likeness or picture, or that of my minor child, in any photograph or advertising for promotion of the Parks and Recreation programs. I hereby acknowledge that this release is voluntarily given with full knowledge of the meaning and consequences of this release.

As further consideration for participation in this activity, I do hereby for myself, my minor child and my heirs, executors, administrators, successors, and assigns agree to release, indemnify and hold harmless the City of Pocatello and its insurers from liability, loss, cost, claim, or damage whatsoever which may be imposed upon the City of Pocatello resulting from the negligence or wrongful acts of the City of Pocatello, its employees or agents.

I understand that this recreation program may be of a hazardous nature and/or include physical and/or strenuous exercise or activity; that serious accidents occasionally occur during sports activities; and that personal injuries and/or property damages as a consequence thereof. Knowing the risks involved, nevertheless, I have voluntarily applied to participate in this activity and I hereby agree to assume for myself and/or minor child all risks of injury or death and to release or hold harmless the City of Pocatello (its officers, employees, and agents) who might otherwise be liable to me.

I understand that I am responsible to provide my own health or my child's health and accident insurance in the case that I or my child is injured while participating in any recreation program. I also understand that I must sign the release form before I or my child may participate in the program.
